MEETING OPENED

Chairman Cross called to order the regular meeting of the Greater Naples Fire Rescue District's Board of Fire Commissioners meeting at 5:30pm., on August 14, 2018 at Administrative Headquarters. Chief Schuldt reported there were a total of 9 Firefighter fatalities for the month of July, bringing the total for 2018 to 58, followed by a moment of silence.

G. Fire Chief's Report

Chief Schuldt presented report as submitted and added the following:

- Doug Holden received notice of a matching kidney donor and travelled to Tampa this morning for surgery. Let's keep him in our thoughts and prayers.
- New Diesel Fuel Tender is parked out front. Cottiers do we have a need for gasoline Fuel Tender? Cross can we use Impact fees? Bishop- Yes. Page can we meter the disbursement? Schuldt yes. Cross put unleaded gasoline fuel tender bought with Impact Fees on September's agenda.
- GNFD received \$48,000 from the sales of surplus vehicles and items.
- The District has received verbal commitment from GAC Land Sales Committee to secure two acres of land located at Golden Gate Blvd. and Desoto Blvd. for the purpose of an additional fire station when needed.
- Page asked if an update on the Union member issue is available. Schuldt it is my understanding the Union is addressing internal issues. Schuldt the District is doing everything to make sure our employees are behaving correctly. The situation has been turned over to our legal team and they are addressing it.

H. Chapter 175 Firefighters' Pension Plan – Chairman Arroyo

Director Bishop stated Chairman Arroyo could not make meeting for medical reasons, but requested a special meeting for the 175 DROP in September. Cross – stated he received letter from Local 2396 President Trenton Mading announcing the Union is in support of proposal brought forward by Arroyo including the higher interest rate. Cross does not want to continue pushing this issue month to month. Page – I would be prepared to make a motion tonight. Commissioner Page made a motion to implement a DROP Plan for the 175 FF Pension Plan to mirror the definition and detail of the FRS DROP. Commissioner Gerrity seconded. Discussion continued among the Board. Commissioner Cross call the question, motion passed 6-0.

Director Bishop presented Rob Potteiger's letter of intent to remain on 175 Pension Plan Board of Trustees. Commissioner Page moved to re-appoint Rob Potteiger to fill the District Resident Trustee Seat #2 on the Chapter 175 Firefighters' Pension Plan Board of Trustees. Commissioner Stedman seconded. Motion passed 6-0.

I. Local 2396 Report

- President Trenton Mading stated negotiations are going slow, but good. Union will present financial packet to management at next meeting on 8/22/18.
- Special meeting scheduled for tomorrow 8/15/18 to discuss Out of Position MOU; either letting it die or extending until contract is ratified.
- Chairman Cross asked about current issue in the news. Mading not going to speak about internal Union issues at a board meeting, but I will say any Charity that has been promised anything from the Union has been made whole.

A. AIW – Brush Truck 71 / Golden Gate Land Trust

Director Bishop presented information from the GAC Land Sales Committee.

Commissioner Cottiers moved to authorize purchasing one new 2019 International 4x4 Type
One brush truck from REV of Ocala and piggyback the Sarasota County bid, value
\$212,725.44; funding as described. Commissioner Page seconded. Motion passed 6-0.

B. AIW- Commissioner Retirement Rate

Director Bishop presented the history of the Commissioner Retirement rates. Cross – how do we move it into the cheapest Elected Official Class and keep the rate as low as possible? Bishop – if in FRS you remain in the regular rate class 8.26% versus Elected Official class 48.7%. Henning – can Commissioner make up the % difference in class using their salary? Page – regardless of intent, is it legal to be in the regular class when you are an Elected Official. Director Bishop will follow up with FRS and report back to Board.

C. AIW – SCBA Purchase

Commissioner Gerrity moved to approve staff's recommendation with the utilization of Impact fees for the purchase of 25 SCBA, 50 air cylinders, 25 facepieces, and 11 amplifiers in the amount not to exceed \$169,814.83, utilizing Orange County Term Contract No. Y17-1095-MV. Commissioner Cottiers seconded. Motion passed 6-0.

D. AIW – Out of Position MOU Extension

Commissioner Stedman moved to approve staff's recommendation to approve the Out-of-Position MOU between the District and Local 2396 be extended through ratification of the new CBA. Commissioner Cottiers seconds. Motion passed 6-0.
