

I. MEETING OPENED

A. AIW- 2019 SHSGP Grant – MARC Unit Region 6 Agreement

B. FDOT MM63 Agreement

Commissioner Stedman made a motion to approve the updated Mile Marker 63 Agreement with FDOT. Commissioner Page seconded. Motion passed 4-0.

C. AIW – Acceptance of FEMA Firefighters Assistance Grant EMW2018-FO-03451 Commissioner Cottiers moved to proceed with accepting FEMA Assistance to Firefighters Grant for a total package of \$610,250.00 with the Federal share being \$554,772.72 and the District's share \$55,477.28. Commissioner Gerrity seconded. Motion passed 4-0.

D. Station 23 – Commissioner Stedman

The Board discussed different options on how to fix the issues with Station 23. It was decided a long term solution is needed. The Board directed Staff to assess options and present at a future meeting.
