Commissioner Cottiers made a motion to approve the Amended FY18-19 General Fund Budget in the amount of \$39,127,678, the Amended FY 18-19 Impact Fee Budget in the amount of \$5,788,646 and the Amended FY 18-19 Hydrant Fund Budget in the amount of \$482,808. Commissioner Page seconded. Motion passed 4-0.
