Guidelines for "Ride Along Program"

The guidelines are as follows:

1. Riders will be restricted to 2 rides per year (one every 6 months), per person. Any request for additional rides must be submitted to the District Chief for special consideration and approval.
2. Other Emergency Service personnel will be allowed unlimited rides.
3. A qualified individual is one that is at least 18 years old, in good health and possesses a valid driver's license. Must bring in a valid driver's license to Headquarters located at 14575 Collier Blvd, Naples, Fl. 34119 before Ride Along approval.
4. Each person shall fill out and sign the required forms (request to ride and the liability form). In addition, they shall read the "Guidelines for the Ride Along Program".
5. Civilians must wear clothing similar to the Fire Department uniform (dark collard, face mask, long pants and closed toe shoes). **ORANGE SAFETY VEST MUST BE WORN AT ALL TIMES.**
6. Riders will obey the orders of the Office in Charge or will be dismissed. **The District at its sole discretion, can end or stop a scheduled Ride Along, for matters of public safety or concern.**
7. The individual shall not interfere with an emergency operation and follow the direction of the Company Officer on duty, at all times including but not limited to Station, Apparatus and on scene of any accident.
8. The individual shall remain in the apparatus upon reaching the scene of any fire or emergency call for safety concerns unless directed to move to a safer location by the Company Officer.
9. Individuals may ride between the hours of 9:00 am and 6:00 pm, Monday thru **Saturday. NO SUNDAYS OR HOLIDAYS.**
10. Fire Prevention Bureau riders will be allowed to ride during normal office hours.
