

I. MEETING OPENED

Chairman Gerrity called to order the regular meeting of the Greater Naples Fire Rescue District's Board of Fire Commissioners at 5:30 p.m., on July 13, 2021 at Administrative Headquarters. Present were Commissioners Duffy, Cottiers, Stedman, Biondo and Gerrity. Staff in attendance: J. Public in attendance: Tara Bishop, Wayne Martin, and George Danz. Others attended meeting but did not sign in.

A. Pledge of Allegiance and Invocation

Commissioner Gerrity opened the meeting with the Pledge of Allegiance followed by the Invocation by Commissioner Stedman.

B. Consent Agenda

Commissioner Stedman moved to approve the Consent Agenda as presented. Commissioner Cottiers seconded. Motion passed unanimously 5-0.

C. Approval, Additions and Deletions to the Agenda

D. Approval of the GNFD Board Minutes for June 8, 2021

Commissioner Cottiers moved to approve the GNFD Board minutes for June 8, 2021 as presented. Commissioner Biondo seconded. Motion passed unanimously 5-0.

E. Fire Chief's Report

Fire Chief Sapp presented his report as submitted.

Fire Chief Sapp announced the Service Awards for the month of June.

Fire Chief Sapp introduced Inspectors and they were officially pinned with their GNFD badge.

F. Chapter 175 Firefighters' Pension Plan – No report was presented.

G. Local 2396 Report

President Joey Brown gave a verbal report on Lieutenant Promotional Testing, two grievances to be heard by the Board of Fire Commissioners, and the ongoing Foundation Lawsuit. President Brown advised he will bring a report next month regarding the Foundation Lawsuit.



II. OLD BUSINESS

A. AIW – Fire Chief Sapp Employment Agreement – Chairman Gerrity

There was a discussion regarding Article 4 of a one-time PEHP of \$10,000 to make up for shortfall. Public comments made by former employee, Tara Bishop questioned health insurance upon separation, coverage provided would be for a period of one month for each two months' service to the District.

Commissioner Duffy moved to approve the contract modifying Article 4 to eliminate the one-time additional payment of \$10,000 which will be subject to review by the Board as a separate item. Motion passed 4-1. (Biondo)

B. Greater Naples Fire Foundation Update – Fire Chief Sapp

Fire Chief Sapp reported mediation will be set up later this month. There is no action required by the District at this time.

C. Training Update – Assistant Chief Krajewski – Not present

Fire Chief Sapp gave a verbal update on the District's Training Section.

III. NEW BUSINESS

A. Commissioner Seats – Commissioner Duffy

Commissioner Duffy recommended the District Fire Commissioner seats move to At Large. District Attorney Laura Donaldson recommended to present a separate bill at the next local delegation meeting.

Commissioner Duffy moved to move forward with pursuing making the District Seats At Large. Commissioner Stedman seconded. Motion passed unanimously 5-0.

B. AIW – Garretto Grievance – Deputy Chief Tobin

Deputy Chief Tobin presented background information on Daniel Garretto's Grievance. Daniel Garretto presented his grievance and provided handouts to the Board of Fire Commissioners.

Commissioner Gerrity moved to support the Fire Chief's position that the employee is not eligible for the ½ bonus point under the relevant contract language. Commissioner Biondo seconded. Motion passed 3-2. (Biondo, Duffy)

C. AIW – Klock Grievance – Deputy Chief Tobin

Deputy Chief Tobin provided an explanation of the collective bargaining process and the offer of new position made to employee to resolve grievance. Khris Klock communicated his grievance to the Board of Fire Commissioners.

Commissioner Biondo moved to support the Fire Chief in considering the grievance closed for further action by the District. Commissioner Cottiers seconded. Motion passed 4-1. (Stedman)

E. Comments by Commissioners
