Commissioner Biondo seconded. Motion passed unanimously 4-0. Commissioner Biondo moved to approve [the letter of intent for the new ladder truck coming off the line]. Commissioner Cherney seconded. Motion passed unanimously 4-0.

Commissioner Cherney moved to provide direction to the County that it is only this Boards desire to increase the impact fee, not to change the methodology for how it was assessed (i.e., was to be on commercial and residential structures not on out buildings). Commissioner Biondo seconded. Discussion Ensued. Commissioner Cherney withdrew his motion and moved to table this topic for the next meeting. Commissioner Biondo seconded 5-0.
