B. AIW-Purchase of Brush Trucks- Interim Fire Chief Wolfe

Interim Fire Chief Wolfe presented the AIW as submitted.

Commissioner Duffy moved to approve the purchase of three (3) custom built brush trucks to be purchased from South Florida Emergency Vehicles not to exceed \$975,000. Commissioner Dearborn seconded. Commissioner Cherney stated he is not opposed to the purchase of brush trucks, but would rather know the trim numbers for next year before committing. Chairman Biondo spoke against the motion as stated. Motion failed 1-4. (Cherney, Dearborn, Biondo)

Commissioner Cherney moved to approve a letter of intent that can be signed for three units with approval to purchase two, with the third one pending the Budget Workshop. Commissioner Duffy seconded. Motion passed unanimously 4-0.

C. AIW-Resolution No. 2024-07 Impact Fees on Accessory Structures- Assistant Chief Hanson Interim Fire Chief Wolfe presented the AIW as submitted.

Commissioner Duffy moved to approve Resolution No. 2024-07 outlining impact fees to be charged on accessory structures. Chairman Biondo seconded. Commssioner Cherney stated the Districts need to be on the same page regarding impact fees. Motion passed unanimously 4-0.

D. Public Input for Issues Not Listed on the Published Agenda

Chief of Staff Chesser announced a comment from the Zoom chat: "Are the Commissioners in support of Article-21 excess BC OT convoluted loophole?"

E. Comments by Commissioners
