I. MEETING OPENED

Chairman Biondo called to order the regular meeting of the Greater Naples Fire Rescue District's Board of Fire Commissioners at 9:00 a.m., on June 12, 2024, at the Administrative Headquarters. Present were Commissioners Biondo, Cherney, Cross, Dearborn (arrived at 9:09) and Duffy.

B. AIW- FY 23 Audit Presentation- David Caplivski, Grau & Associates

David Caplivski, Grau & Associates presented the draft Audit via zoom.

Commissioner Cherney moved to accept the Greater Naples Fire Rescue District Financial Report for the Fisical Year ended September 30, 2023 into official record as presented by Grau & Associates. Commissioner Cross seconded. Motion passed unanimously 5-0.

C. AIW- Disaster Policies- Interim Fire Chief Wolfe

Interim Fire Chief Wolfe presented the AIW as submitted.

Commissioner Cross moved to approve the Chief to be deployed internally and externally to be paid overtime in accordance with his hourly rate. Commissioner Dearborn seconded. Discussion ensued and clarified the motion is Option #2 in the AIW. Motion passed 4-1 (Dearborn).

D. AIW- Third-Party ITM Reporting- Assistant Chief Hanson

Assistant Chief Hanson presented the AIW as submitted.

Commissioner Cross moved to approve Staffs request for the AIW with the \$5.00 cost share and for this to start October 1, 2024 and to allow the Fire Chief to sign the contract after it has been approved by legal. Commissioner Dearborn seconded. The Board directed Attorney Donaldson to review the contract for any legal issues. Motion passed unanimously 5-0.

E. AIW- Local 2396 Collective Bargainging Agreement Ratification- Interim Fire Chief Wolfe Interim Fire Chief Wolfe presented the AIW as submitted.

Commissioner Cross moved to approve Collective Bargaining Agreement as approved by the Union. Commissioner Dearborn seconded. Commissioner Cherney announced his concerns regarding Article 15-Drugfree Workplace; discussion ensued. Commissioner Cherney requested Article 15- Drug Testing to be a mandatory re-opener. Wayne Martin and George Danz addressed their concerns with the contract. Motion passed unanimously 5-0.

F. AIW- FY 24-25 Budget Meeting Schedule- Chief of Staff Chesser

Chief of Staff Chesser presented the AIW as submitted.

Commissioner Cross moved to approve the Budget Meeting schedule as presented by Staff and to change the time for September 12, 2024 BOFC meeting to 5:30. Motion passed unanimously 5-0. Commissioner Cross moved to approve [the Workshop date] July 10, 2024 to occur at the end of the Greater Naples Fire meeting. Motion passed unanimously 5-0.
