## II. OLD BUSINESS

## A. Yacono HMGP Project- Deputy Chief Bauer

There was discussion regarding the County not wanting to take the Yacono project over. The Board agreed to submit a letter of support in order to receive a contract from FEMA. Attorney Donaldson will review the contract to ensure there is no financial impact on the District.

## C. AIW- Tablet Command Interlocal Agreement Amendment- Fire Chief Wolfe

Commissioner Cross moved to approve the Interlocal Tablet Command Agreement. Commissioner Cherney seconded. Motion passed unanimously 5-0.

## D. Sunny Grove Rd. – Commissioner Duffy

Chairman Biondo requested any additions to the Agenda be requested under Comments by Commissioners. Commissioner Duffy stated that Sunny Grove area is not passable by emergency vehicles and citizens are requesting the District send the County a letter regarding the issue. Commissioner Cross moved to have Staff draft a letter of support for the County to repair private roads that impact emergency response. Commissioner Cross withdrew his motion.

Wayne Martin stated he believes the County has a special taxing District to maintain private roads. The Board supported sending the County a letter to address the private roads.

## F. Comments by Commissioners
