

#### FINAL APPROVED MINUTES GREATER NAPLES FIRE RESCUE DISTRICT BOARD OF FIRE COMMISSIONERS MEETING JANUARY 8, 2024

# I. MEETING OPENED

# B. AIW- Legislative Representation- Fire Chief Wolfe

Fire Chief Wolfe presented the AIW as submitted. Commissioner Cross moved to approve the legislative representation agreement with Laura Donaldson's firm, not to exceed \$2,000 [for expenses] for the local bill. Commissioner Dearborn seconded. Motion passed unanimously 5-0.

# C. AIW- Division Chief Job Description- Fire Chief Wolfe

Fire Chief Wolfe presented the AIW as submitted. There was a discussion regarding the Division Chief salary.

Commissioner Duffy moved to approve the Division Chief of Fire Training job description as presented. Commissioner Dearborn seconded. Commissioner Duffy withdrew his motion. Fire Chief Wolfe will re-present the Division Chief job description after discussions with each of the Commissioners.

# D. AIW- Commissioner Officer Elections- Chief of Staff Chesser

Chief of Staff Chesser presented the AIW as submitted. Commissioner Cross moved to nominate Commissioner Biondo for the position of Chair. Commissioner Dearborn seconded. Motion passed unanimously 5-0. Chairman Biondo moved to nominate Commissioner Cherney for the position of Vice-Chair. Commissioner Cross seconded. Motion passed unanimously 5-0. Commissioner Dearborn moved to nominate Commissioner Cross for the position of Secretary. Chairman Biondo seconded. Motion passed unanimously 5-0. Commissioner Cross moved to nominate Commissioner Dearborn for the position of Treasurer. Chairman Biondo seconded. Commissioner Dearborn declined the position of Treasurer. Chairman Biondo seconded. Commissioner Dearborn declined the position of Treasurer. Commissioner Cross moved to nominate Commissioner Duffy for the position of Treasurer. Chairman Biondo seconded. Motion passed unanimously 5-0.

# E. Public Input Not Listed on the Published Agenda

George Danz stated the East Naples Civic and Commerce opposed the District Wide Election seats.

# F. Comments by Commissioners

There was discussion regarding Commissioner Dearborn's insurance invoice due to his absences. *Commissioner Cross moved to approve those two absences due to the death of his family to make them be excused and get him below the threshold. Commissioner Duffy seconded.* Chief of Staff Chesser stated the Policy doesn't have an exemption for excused absences and the Board would need to revise the policy. *Commissioner Cross withdrew his motion.* 

Commissioner Cross moved to amend that [the policy] to allow it [the absences] to remain at three for excused absences, that the Board approves the excuse, based on the three criteria listed: medical reasons, family emergencies, death in the family or unavoidable absences (such as travel delay), those will count as excused absences and will not go towards the total of three. Commissioner Duffy seconded. Discussion ensued. Commissioner Cross withdrew his motion.

Commissioner Cross moved to waive this penalty against Mr. Dearborn based on extenuating circumstances with family death. Commissioner Duffy seconded. Motion passed unanimously 5-0.
