#### B. AIW- New Brush Truck for Station 26- Deputy Chief Bauer

Commissioner Cross moved to approve the purchase of the Brush Truck for \$374,072. Commissioner Duffy seconded the motion. Commissioner Cherney expressed concern about purchasing the brush truck for Station 26, noting that the station is not expected to be operational for another 2.5 to 3 years. Discussion followed regarding the potential benefits of delaying the purchase, including the opportunity to better utilize impact fees rather than capital funds. It was also noted that the District has limited vehicle storage capacity, and this purchase would necessitate an additional vehicle being stored outdoors. Commissioner Cross withdrew the motion, and Commissioner Duffy withdrew the second.

# C. AIW- Water Tender Purchase- Deputy Chief Bauer

Commissioner Cross moved to approve the Water Tender purchase at \$529,592. Commissioner Cherney seconded. Motion passed unanimously 5-0.

#### D. AIW- Station Security and Radio Purchase- Deputy Chief Bauer

Deputy Chief Bauer presented AIW as submitted. Commissioner Cross moved to approve the Motorola Security System Radio Equipment. Commissioner Cherney seconded. Motion passed unanimously 5-0. Commissioner Cherney requested to be on record that the equipment would be able to be relocated to other stations if needed, Deputy Chief Bauer confirmed that equipment can be relocated as needed.

#### E. AIW- Promotional Plan Phase 3/Temporary Positions MOU- Deputy Chief Diaz

Deputy Chief Diaz presented AIW as submitted. Commissioner Cross moved to approve the Promotional Plan Phase 3 and Temporary Positions MOU. Chairman Biondo seconded. Motion passed unanimously 5-0.

#### F. AIW- Procurement Policy Revision- Fire Chief Wolfe

Fire Chief Wolfe presented AIW. Commissioner Cross moved to approve District Procurement Policy. Commissioner Cherney seconded. Motion passed unanimously 5-0.
